

## Sleepy Hollow Conservation Club

### Polices

4-18-19

1. All members will sign the Sleepy Hollow Conservation Club, Release and Indemnification Agreement.
2. *Non-members participating in a firearm event at Sleepy Hollow Conservation Club, shall sign a Release & Indemnification Agreement. Tabled 1-22-02*
3. **All participants** at any shooting event, in a group or alone, must follow the posted range rules and or the range officer. *Range Officer has vest or arm band.*
4. **Ear and eye** protection must be worn during a shooting event or where a firearm is discharged.
5. All **gun ranges closed** one week before firearm deer season through Dec. 1<sup>st</sup> .
6. **No hunting** on Sleepy Hollow Conservation Club property.
7. No driving vehicles on the **dam**.
8. Only **catch and release fish** from our pond permitted.
9. **Use of Club House**, Pavilion and range: Reserve your date with President, President has master calendar. Grounds are still open to club members but being courteous to the event.
10. **Alcohol** is allowed in moderation (DO NOT MIX ALCOHOL AND GUNS)  
Please do not spoil this policy for the next person.
11. **Campfires** are allowed, you are in control and responsible of the fire. Fire must be completely extinguished when you leave SHCC. A sign will posted if a fire BAN is on (NO FIRES)

### **Leave no trash, clean up your area, take your trash with you.**

13. **Shooting hours:** Daylight savings 9:00AM – 10:00PM Regular time 9:00AM – 9:00PM
14. Normally a **Spring & Fall clean up** will be scheduled. Your participation makes short work with some time for fellowship and fun.
15. **Pets** are allowed as long as you have them under control and they are not bothering other members.  
**Please clean up after your pet.**
16. Treasurer will provide an **end of year financial report**.
17. *The Club President, Vice President, Secretary, and Treasurer pay no dues during their year (s) in office. Officers will pay mowing fee.*
18. **New Member dues** @\$10.00 new member fee & \$60.00 per full year - pro rated for partial year plus grass mowing fee which determined @ Annual meeting.
19. **Renewal Member dues** @ \$60.00 per year plus grass mowing fee which is determined @ Annual meeting.
20. **Late paid Member dues** @ \$80.00 per year plus grass mowing fee which is determined @ Annual meeting (paid after March meeting)
21. **After March** membership meeting or postmark of March membership meeting, the Treasurer will retain \$10.00 of all late dues.
22. **Dues are paid** annually and keys are exchanged annually.
23. *No one under the age of 18 shall enter, use SHCC property and the facility with out adult member supervision present.*
24. *You are responsible for your membership key, please do not loan the key out.*
25. **Lost key charge** \$10.00
26. *Voting on new members, Prospective new member or prospective new member sponsor must be at the SHCC meeting in which said prospective new member is voted upon, membership is tabled until next meeting and policy conditions are meet.*
- 27) *New Member Applicants to be voted on after March 16th, 2017 must live in an approximant 12 mile radius of the SHCC*
